The SEANNA, SWANES of Section 5, Township 41 South, Range 12, E.W.M., EXCEPTING that portion more particularly described as follows:

A parcel of land in the Northwest corner of the SELNWA, Section 5, Township 41 South, Range 12, E.W.N.; said parcel being 160 feet extending East and West and 200 feet North and South and being further described as follows: Commencing at the Northwest corner of the SEANT of Section 5, Township 41 South, Range 12, E.W.M.; running thence East along the 40 line a distance of 160 feet; thence South 200 feet; thence West 160 feet; thence North to the point of beginning. ALSO EXCEPTING THEREFROM the Westerly 30 feet of said SELNING.
