and covenant that grantors are the owners of the above described property free of all encumbrances except encumbrances created by grantee, subsequent to October 1, 1971; rights of way for ditches, laterals, canals and roadways, if any; provisions and restrictions as set out in Deed from grantors to the State of Oregon, by and through its State Highway Commission, dated July 24, 1952, and recorded August 4, 1952, in Vol. 256, page 119, Deed Records of Klamath County, Oregon; right of way granted to the Pacific Telephone and Telegraph Company by Deed dated September 4, 1928, recorded October 10, 1928, in Vol. 82, page 359, Deed Records of Klamath County, Oregon; and acreage and use limitations under provisions of the United States Statutes and Regulations issued thereunder, and will warrant and defend the same against all persons who may lawfully claim the same except as shown above.

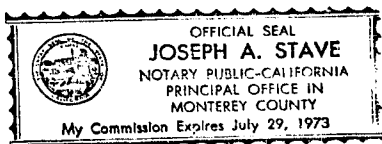
