DECREE OF DISSOLUTION
OF MARRIAGE

11 THIS MATTER came on for hearing on April 12, 1973.
12 Petitioner appeared in person and by Robert F. Nichols, her
13 attorney. The Respondent and his attorneys made no appearance.

15 The Court finding that irreconcilable differences exist
16 between the parties making continuation of the marriage relation-
17 ship impossible and that the parties were married on June 30, 1967
18 at Klamath Falls, Oregon and that one minor child has been born
19 during this marriage, namely J. Derek Thurman, born November 26,
20 1967, now therefore;

21 IT IS HEREBY DECREED THAT:

22 (1) The marriage of the parties is hereby dissolved and
23 said dissolution is finally effective June 12, 1973.

24 (2) Petitioner shall have the care, custody and control
25 of the minor child of the parties, J. Derek Thurman, subject to
26 the Respondent having the right of reasonable visitations at such
27 times and places as will not interfere with said child's health,
28 welfare and education.

29 (3) Each of the parties is awarded his or her own per-
30 sonal effects and household furniture and fixtures now in their
31 respective possession.

32 (4) The Petitioner is awarded the 1968 Chevrolet Impala

3 (5) The Respondent is awarded all of the parties' equity
4 in the real property located at 3840 Kelley Drive in Klamath
5 Falls, Oregon, described as Lot 4 in Block 2 of Kelene Gardens in
6 Klamath County, Oregon, subject to the Respondent assuming all
7 indebtedness thereon and paying all medical bills which he incurred
8 which are approximately \$2,000 to the Rehabilitation Institute of
9 Oregon, \$1,050 to Dr. Campagna, \$900 to Presbyterian Intercommunity
10 Hospital and any balance due to Dr. Dobry, holding the Petitioner
11 harmless from further liability on any of said obligations.

12 (6) The Petitioner is awarded the sum of \$117.00 per
13 month which is the present social security benefits allowable for
14 the care and support of said minor child. If for any reason said
15 social security benefits shall terminate, then the Respondent
16 shall pay to the Petitioner in lieu thereof the sum of \$100.00
17 per month, in which case said payments shall commence on the 5th
18 day of the month following the termination of social security
19 benefits and be payable through the County Clerk of Lake County,
20 Oregon as required by law.
