## **EASEMENT**

KNOW ALL MEN BY THESE PRESENTS, That Mrs. C. A. HENDERSON 1972 Earle Avenue, Klamath Falls, Oregon 97601 for and in consideration of the sum of ONE DOLLAR and other valuable consideration to him, it or them, paid by South Suburban Sanitary District of Klamath County, Oregon, do hereby grant to the said South Suburban Sanitary District of Klamath County, Oregon, its successors and assigns, an easement for a sewer in and across the following described real estate, situate, lying and being in Klamath County, Oregon, and more particularly described as follows:

A strip of land 10 feet in width lying about the following described center line: Beginning at a point on the East right-of-way boundary line of the Bureau of Reclamation 1-C-1-A drainage ditch, said point located 200 feet northerly of the intersection of the South boudary line of Section 12, TWP 39 S, R 9 EWM and the afore mentioned 1-C-1-A drain R.O.W. boundary; thence easterly, parallel to and 200 feet northerly of the southern boundary of Section 12, TWP 39 S, R 9 EWM for a distance of 450 feet more or less to a boundary of Section 12, TWP 39 S, R 9 EWM for a distance of 450 feet more or less to a point of intersection with the southerly boundary line of the Bureau of Reclamation A-canal irrigation ditch.

together with the right to use so much of the adjoining land as is reasonable and necessary in connection with the original construction of the sewer.

The foregoing easement is made, executed and delivered to the grantee herein upon the following

-1. The grantee agrees to indemnify and save harmless the grantor from and against any damage, Express terms and conditions, to-wit: Poss, cost and expense, which the grantor may sustain resulting directly or indirectly in any manner from The use of said premises and/or the construction, maintenance, use and/or location of the said sewer in

2. The grantee, and the agents and employees of the grantee, shall have the privilege of entering and across said premises. upon said premises for the purpose of making necessary repairs to or changes to said sewer.

The said sewer shall be placed underground in the usual manner and grantee agrees to replace the surface of the ground above the sewer in substantially its present condition and repair or replace any damaged facilities, and agrees that grantor shall have full and unrestricted use of the surface of said ground except during the period of sewer construction and during the period of any repairs that may be necessary. Said surface shall be replaced in approximately its present condition following such repairs.
