NOTICE is hereby given that JIM L. SHELBY, dba R & S CONTRACTING CO. claims a lien upon pine logs of sawmill stud lengths being about 130,000 board feet, more or less, which were cut in Klamath County, State of Oregon, generally with an orange dot or an orange S or other such marking, and are now lying in the dry deck area of Frank Kimble Saw Mill south of the town of Lakeview in Lake County, State of Oregon, and 50,000 board feet more or less lying upon the ground in Section 13, 15, 23, 24 and 25 in Township 37 S. Range 15 EWM and Sections 6, 8 and 30, Township 37 S Range 16 EWM in Klamath County, Oregon, for labor performed upon and assistance rendered in cutting the logs. That the name of the owner or reputed owner is Frank Kimble; that A. H. Strain employed the claimant to perform such labor and render such assistance upon the following terms and conditions:

Claimant was to receive \$11.50 per thousand board feet for cutting. Claimant cut 259,625 board feet and has been paid for 79,080 board feet (\$909.42) leaving a balance of 180,545 board feet for \$2,076.27.

That the contract has been faithfully performed and fully complied with on the part of Claimant who performed labor upon and assisted in cutting for the period from March 21, 1973 to May 6, 1973; and the rendition of such services was closed on the 6th day of May, 1973 and 30 days have not elapsed since that time; that the amount of claimant's demand for services is \$2,076.27 after all setoffs, payments and counterclaims and there is now due

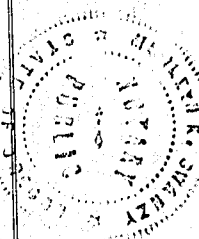
