That portion of Lot 35, Block 37, Klamath Falls Forest Estates, Highway 66, Unit Two, beginning at a point on the northeast boundary of said Lot, approximately 66' 10" southeasterly from the northernmost corner of said Lot; — thence southwesterly approximately 548 feet along a line parallel to the southeast boundary of said Lot to a point on the southwest boundary of said Lot; — thence northwesterly approximately 66' 7" along the southwest boundary of said Lot; — thence northeasterly approximately 524 feet along a line parallel to the northwest boundary of said Lot to the point of beginning.
