## NOTICE OF LOGGER'S LIEN

Notice is hereby given that Al Strain claims a lien upon 115,210 feet of logs or lumber, rails and ties manufactured therefrom which were cut in Klamath County, State of Oregon, and manufactured in Lake County, State of Oregon, and are marked with an orange or red stripe or "S" on the butts and tops of logs and end of manufactured lumber, rails or ties and are now lying in the mill site of Custom Cedar Mill in Lakeview, Lake County, State of Oregon, for labor performed upon and assistance rendered in cutting said logs. The name of the owner, or reputed owner, is Frank Kimbler, K. & C. Lumber and Custom Cedar Mill and all other persons unknown having an interest in and doing business under these names, and that Frank Kimbler employed Al Strain to perform such labor and render such assistance upon the following terms and conditions: Logging 51,090 feet at \$90.00 per thousand and 64,120 feet at \$80.00 per thousand equalling \$9,727.70. The contract has been faithfully performed and fully complied with on the part of Al Strain who performed labor upon and assisted in cutting and hauling or otherwise logging said timber. Said labor and assistance were so performed and rendered upon the property between the 15th day of April, 1973, and the 13th day of June, 1973, and the rendition of such services was closed on the 13th day of June, 1973, and 30 days have not elapsed since that time. The amount of claimant's demand for the services is \$9,727.70 and no part thereof has been paid except \$2,500.00 and there is now

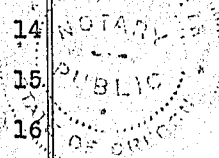
