

interest, do hereby grant unto the District, its successors
and assigns an easement for water pipelines which are and assigns, an easement for water pipelines, which are a necessary part of the District's water distribution system, 57 57 necessary part of the District's water distribution system, with all fixtures, devices and appurtenances necessary to the operation of said pipelines, within, over and across the following described land situated in the County of Klamath, State of Oregon: A strip of land 22.00 feet in width, more particularly described as follows: The North 22.00 feet, the East 22.00 feet, and the South 22.00 feet of the East 850.00 feet, lying North of Transformer Road, all in the Southwest Quarter (SW 1/4) of the Northwest Quarter (NW 1/4) of Section 5, and the South 22.00 feet of the West 30.00 feet, lying North of Transformer Road, in the Southeast Quarter (SE 1/4) of the Northwest Quarter (NW 1/4) of said Section 5, T. 41 S., R. 12 E., Willamette Meridian, Klamath County, Oregon. Together with a 20.00-foot-wide Temporary Working Easement lying South, West, and North of the above-described Permanent Easement.



6. The District may assign the easement granted herein to the United States of America subject to the terms hereof.

7. In case of permanent abandonment of said right-of-way, the title and interest herein granted shall end, cease, and terminate.
