KNOW ALL MEN BY THESE PRESENTS that heretofore there was issued to William Kittredge certificate of water right No. 7374 upon certain lands located in the Klamath Marsh within Klamath County, Oregon, which certificate of water right was recorded in Volume 2 at page 190 of the Record of Water Rights for Klamath County, Oregon; and,

WHEREAS, said William Kittredge died testate and under and by virtue of the terms of his Last Will and Testament, which was duly admitted to probate, Donovan L. Nicol and Ray J. Michels were named as executors of his estate; and,

WHEREAS, under and by virtue of the terms of the Last Will and Testament and the probate of said estate, the lands covered by said water right certificates were distributed and divided among the following-named persons: Donovan L. Nicol; and,

WHEREAS, the parties now desire to make a record of the division of said lands and the appurtenant water rights thereto;

NOW, THEREFORE, the parties do declare that said water rights and the lands to which they are appurtenant are divided as set forth on the hereunto attached Schedule A, which is hereby referred to and by this reference made a part hereof. That this declaration is made for the purpose of making a matter of record the transfer and division of said water rights under said certificate 7374 and shall constitute an assignment of such water rights to the respective lands described on such Schedule A.
