COOFS WARRANTY DEED

Roper and Gertrude Roper, husband and wife, dated May 26, 1939, recorded February 27, 1943, Deed Vol. 153, page 247, records of Klamath County, Oregon, as follows: "...excepting and reserving to first parties, their heirs and assigns, the right at any time to construct, build and erect ditches, telephone lines, telegraph lines and electric power lines in and upon said premises and to keep and maintain same, said right to be for benefit of lands and premises adjacent above described land."
