after called Grantor, conveys to the PUBLIC an easement for road  
purposes on all that real property situated in Klamath County,  
State of Oregon, described as:

Commencing at the Southwest corner of the Northeast  
1/4 of the Southwest 1/4 of Section 3, Township 23  
South, Range 9 East of the Willamette Meridian in  
Klamath County, Oregon and running East along the  
South boundary line of said Northeast 1/4 of the South-  
west 1/4 to the Southeast corner; thence North 30 feet;  
thence West parallel to the South boundary of said North-  
east 1/4 of the Southwest 1/4 to a point 200 feet East  
of the West boundary of the Northeast 1/4 Southwest 1/4;  
thence Northwesterly to a point on the Westerly Boundary  
of said Northeast 1/4 Southwest 1/4, said point being  
a distance of 60 feet North of the Southwest corner of  
the said Northeast 1/4 of the Southwest 1/4; thence  
South along the boundary line between Sections 3 and 4  
to the point of beginning.

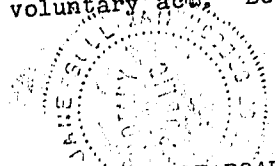
