Portion of Lot 14, Section 14, Township 36 S., Range 10 EWM Klamath County, Oregon, beginning at point which is south 1980 feet and east 1933 feet and south 460 feet from north-west corner of Section 14; thence south 100 feet; thence east 120 feet; thence north 100 feet; thence west 120 feet more or less to point of beginning, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

Subject to all encumbrances, reservations, restrictions, and rights-of-way of record and those apparent upon the land.

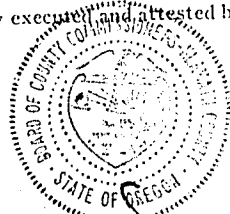
