

GENERAL POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS:

I, DONNA HAMET, a resident of Santa Cruz County, California, do by these presents appoint MEHMET MATT AHMET, my husband, Santa Cruz, California, as my attorney in fact, for me and in my name, and for my use and benefit; to demand, sue for, collect, and receive all such sums of money, debts, dues, accounts, interests, dividends, and demands whatsoever, as are now or shall hereafter become due, owing, payable, or belonging to me and have, use, and take all lawful ways and means in my name or in his name, for the recovery thereof by filing causes of action, attachment, execution, or otherwise, and to compromise and agree for the same, and discharge the same for me and in my name; to lease, let, or rent lands and real property in my name upon such terms and conditions, and under such covenants as he shall think fit; to bargain for, buy, sell, and in any way and every way and manner deal in and with goods, wares, and merchandise, choses in action, and other property in possession or in action, and to do every kind of business of what nature or kind soever; and also for me and in my name, and as my act and deed to make and deliver leases and assignments of lease, and to make, sign, execute and deliver checks, bills of exchange, notes, receipts, releases, and such other instruments in writing of whatever kind and nature as may be necessary, and convenient, to care for my properties, both real and personal; to accept, endorse and deposit any and all notes, checks, bank drafts, or bills of exchange made out to me as payee; to bargain, sell, assign and transfer corporate stocks and bonds in my name and stead, and for that purpose to make and execute all necessary acts of assignments and transfer thereof; also, in case of loss or losses by fire, or otherwise, to adjust insurance losses.

FURTHER GIVING unto my said attorney full power to perform every act and thing which I may think necessary to be done in and about the premises, as fully to all intents and purposes as I might or could do if personally present; and I hereby ratify and confirm all that my said attorney, MEHMET MATT AHMET, shall lawfully do or cause to be done by virtue of these presents.

This power of attorney shall remain in full force from August 24, 1973 to and including February 1, 1974 at which time this power of attorney shall lapse.

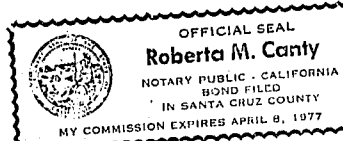
This power of attorney may be recorded by my said attorney, MEHMET MATT AHMET, with the County Recorder of any County in which he deems it convenient or necessary.
