7 WHEREAS, the City of Malin, Oregon, did by Ordinance No. 143  
8 adopted February 6, 1973, propose to annex to said  
9 City and include in the boundaries thereof the territory herein-  
10 after described, and did by said Ordinance call a public hearing  
11 May 1, 1973, to be held in the  
12 City Hall of said City, where and when  
13 registered voters of said City might be heard, which meeting was  
14 duly advertised by notices published and posted as required by  
15 law, proof of such publishing and posting of notices being on  
16 file herein; which meeting and hearing was held as provided by  
17 said Ordinance and notice; and

18 WHEREAS, after more than 30 days had elapsed after the  
19 adoption of said last described ordinance and it had not been  
20 referred to the voters of the City of Malin, by referendum;  
21 and the Council being fully informed:

22 THE CITY OF MALIN DOES ORDAIN AS FOLLOWS:  
23 Section 1: That there by and is hereby annexed to and  
24 included within the bounds of the City of Malin, Oregon, territory  
25 adjacent and contiguous to said City and described as follows:

26 A piece or parcel of land containing 7.5 acres,  
27 more or less, and situated in the NE 1/4 NE 1/4  
28 of Section 16, T41S, R12EWM, in Klamath County,  
29 Oregon, and more particularly described as follows:

30 All of that portion of the said NE 1/4 NE 1/4 of  
31 Section 16, T41S, R12EWM, lying Easterly of the  
32 Easterly right of way line of the U.S. Bureau of  
Reclamation "D" Canal; thence Westerly of the  
Westerly right of way line of the Malin Irrigation  
District High Line Canal, and Southerly from a line  
parallel with and 695.0 feet at right angles

1 Southerly from the section line marking the  
2 Northerly boundary of the said Section 16.

3 Section 2: That the Recorder of the City of Malin,  
4 Oregon be and he is hereby authorized and directed to forthwith  
5 forward a certified copy of this ordinance to each of the following,  
6 to-wit: Secretary of State of Oregon; Clerk of Supreme Court of  
7 Oregon; County Clerk of Klamath County, Oregon; County Assessor of  
8 Klamath County, Oregon; and that the copy forwarded to the said  
9 Secretary of State be accompanied with certified copies of each  
10 ordinance in this matter.
