

MECHANIC'S LIEN.

KNOW ALL MEN BY THESE PRESENTS, That the undersigned, designated the "Claimant," did, between the dates of June 25, 1973, and August 6, 1973, furnish materials to and perform labor for and at the special instance and request of E. DAVID LADD, hereinafter designated "Owner", to be, and which were used in the drilling and casing of a well upon certain lands situated in the County of Klamath, State of Oregon, and described as follows:

A tract lying within the SE $\frac{1}{4}$  of the NE $\frac{1}{4}$  and NE $\frac{1}{4}$  of the SE $\frac{1}{4}$  of Section 22, Township 39 South, Range 8 East, W. M.

That at the time Claimant commenced to furnish said materials and perform said labor, E. DAVID LADD was the owner or reputed owner of said land, and E. DAVID LADD is now the owner or reputed owner of the above-described land and the well thereon, and had knowledge of and consented to the drilling and improvement of said well;

That the contract price and reasonable value of said materials furnished and labor performed by the Claimant as aforesaid was and is the sum of \$826.00, lawful money of the United States of America, and there is now due the Claimant on said materials furnished and labor performed, after deducting all just credits and offsets, the sum of \$526.00.

That the following is a true statement of Claimant's demand with all just credits and offsets deducted:

That this Claimant claims a lien for the amount of the above claim upon the land hereinabove described, together with a convenient space about the same, or so much as may be required for the convenient use thereof, to be determined by the judgment of the Circuit Court at the time of the foreclosure of this lien.

That the time in which the Claimant has to make and file this claim of lien on said property with the County Clerk of the County in which said land is situated has not expired. Sixty days have not elapsed since the completion of said contract.
