DESCRIPTION OF PROPERTY

All the following described real property situate in Klamath County, Oregon:

A parcel of land situated in the SW 1/4 SE 1/4 of Section 1, Township 39, South, Range 9 East, W. M., Klamath County, Oregon more particularly described as follows:

Beginning at a brass bolt on the intersection of the centerline of the Dalles California highway and the south line of said Section 1, said point being S. 89°56' W. a distance of 17.90 feet from the southwest corner of the SE 1/4 SE 1/4 of said Section 1 as shown on Survey No. 590 recorded in the office of the Klamath County Surveyor; thence N. 46°09' W. along the centerline of said highway a distance of 356.00 feet; thence N. 17°48' W. a distance of 63.18 feet to the intersection of the southwesterly bank of the Enterprise Irrigation District canal and the northeasterly right-of-way line of said highway; thence N. 17°48' W. along the right-of-way line of the canal 358.00 feet to the true point of beginning of the description; thence S. 43°51' W. 170.00 feet to the northeasterly right-of-way line of the State Highway; thence N. 46°09' W. along the highway right-of-way 110.00 feet; thence N. 43°51' E. 209.77 feet to the southerly right-of-way line of the irrigation canal; thence S. 07°58' W. along the canal right-of-way 49.08 feet; thence S. 17°48' E. along the canal right-of-way line 92.3 feet to the point of beginning less any land lying inside the State Highway right-of-way.
