## O R D E R

WHEREAS on the 29th day of June, 1973, Robert D. Nelson  
and Susan L. Nelson signed and filed a Petition to Vacate the  
following described property:

Beginning at the NW corner of Lot 13, Schiesel  
Tracts, a recorded subdivision in Klamath  
County, Oregon, which is the point of beginning  
of this description; thence South 0°09' West  
along the West side of Lot 13, 89.7 feet;  
thence South 89°13' West 25 feet to the West  
boundary of Schiesel Tracts; thence North 0°  
09' East 89.7 feet to the NW corner of Schiesel  
Tracts; thence North 89°13' East, 25 feet to  
the point of beginning.

WHEREAS a hearing was set, first for the 19th day of  
September, 1973, and later for the 3rd day of October, 1973, in the  
Commissioners' Hearing Room, Klamath County Courthouse, Klamath  
Falls, Oregon; and

WHEREAS a Board hearing was held at the hour of 10:30 a.m.  
on the 3rd day of October, 1973, in the Board of Commissioners'  
Hearing Room, in the Klamath County Courthouse, Klamath Falls, Oregon;

WHEREAS, notices of said hearing were posted in three con-  
spicuous places in the Schiesel Tracts; 30 days prior to the time  
set for the hearing; and

WHEREAS notice of the hearing was published in the Herald  
and News newspaper for four consecutive weeks prior to the time of  
the hearing.

IT IS HEREBY ORDERED that that portion of Logan Street  
in the Schiesel Tracts, an incorporated subdivision, located in
