## <u>O R D E R</u>

This matter having come on for hearing upon the application of Sprague River Pines, Inc. for a change of zone, said change application being numbered Zone Change 73-76 and said application having been heretofore recommended from F (Forestry) zone to SP-1 (Rural Residential) zone by the Klamath County Planning Commission, a description of the real property referred to in said application being marked Exhibit B and A, attached hereto and by reference made a part hereof, and a public hearing on said application having been regularly held on October 2, 1973 before said Board of Commissioners, and the Board of Commissioners having heard and examined the statements and evidence both oral and documentary introduced at said public hearing by the applicant, interested parties, the Planning Commission and the Planning Department, and the Board of Commissioners finding, as required by Ordinance Number 17, the same being the Klamath County Zoning Ordinance:

1. That the applicant has a currently approved preliminary plat which was approved prior to the adoption of county-wide zoning on December 7, 1972, and that the applicant had work substantially complete on the plat which would be recorded in 1973; and

2.
