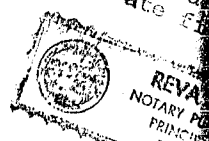

15 order.

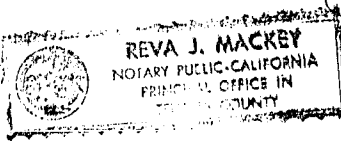
