ORDINANCE NO. 343

WHEREAS, by resolution heretofore adopted, the Common Council  
of the City of Chiloquin, Oregon, upon it's own investigation and  
initiation found that it is for the best interest of the public, that  
a certain portion of Yahooskin Street, being more particularly described  
as follows, should be vacated:

All that portion of Yahooskin Street lying be-  
tween the Westerly boundary of 3rd street and  
the Easterly boundary of Valley Street all of  
the City of Chiloquin, Oregon.

WHEREAS, the Common Council of the City of Chiloquin, Oregon,  
did by said Resolution fix the hour of 8:00 p.m. of the 8th day of  
October, 1973, and the Council Room in the City Hall of said City, as  
the time and place, when a public hearing would be held, at which  
objections and remonstrances made in writing and filed with the City  
Recorder for said City, or made by the public at said meeting, would  
be heard and considered; which hearing was continued until the 23rd of  
October, 1973 at 8:00 p.m. and was duly held; and affidavit of posting  
notices of said hearing being also filed herein; and no objections or  
remonstrances having been filed or offered at said hearing; and  
certificate of the City Recorder being filed herein to the effect that all

1 said property to be vacated is a dedicated street and as such there are  
2 no unpaid taxes or city liens against it, and it appearing to the Common  
3 Council that the market value of property abutting the portion of  
4 Yahoooskin Street to be vacated will not be substantially affected by  
5 the vacation, now, therefore,

6 THE CITY OF CHILOQUIN DOES ORDAIN AS FOLLOWS:

7 Section 1: That a certain portion of Yahoooskin Street, more  
8 particularly described as follows:

9 All that portion of Yahoooskin Street lying  
10 between the Westerly boundary of 3rd street  
11 and the Easterly boundary of Valley Street  
12 all of the City of Chiloquin, Oregon.

13 be and it hereby is vacated.

14 Section 2: The City Recorder is hereby directed to file  
15 certified copies of this ordinance with the following offices, to-wit:  
16 The County Clerk of Klamath County, Oregon, for recording in Deed  
17 Records, the Assessor and Surveyor of said Klamath County, for use in  
18 their respective offices.
