THE DESCRIPTION OF THE
VACATION OF YAHOSKIN STREET
AND DECLARING AN EMERGENCY.

ORDINANCE NO. 377

WHEREAS, the description contained in the heading, first
Whereas clause and Section 1 of Ordinance No. 343 was incorrect,
and

WHEREAS, the City desires to have the right description
used, now therefore,

THE CITY OF CHILOQUIN DOES ORDAIN AS FOLLOWS:

Section 1: The property description used in the heading,
first Whereas clause, and Section 1 of Ordinance No. 343 be
amended to read as follows:

Beginning at the N. W. corner of Lot 1, Block 7;
thence S. 63° 08' E. along the North line of Lot 1
110 ft. to the N.E. corner of Lot 1, Block 7; thence
N. 26° 52' E. 60 feet to the S. E. corner of Lot 5
Block 6; thence N. 63° 08' W. 110 feet to the S. W.
corner of Lot 5, Block 6; thence S. 26° 52' W. 60
feet to the Point of beginning, all located in
First Addition to Chiloquin.

Section 2: The City Recorder is hereby directed to
file certified copies of this ordinance with the following
offices, to-wit: The County Clerk of Klamath County, Oregon,
for recording in Deed Records, the Assessor and Surveyor of said
Klamath County, for use in their respective offices.
