Eeginning at the N. W. corner of Lot 1, Elock 7; thence S. 63° 08' E. along the North line of Lot 1 110 ft. to the N.E. corner of Lot 1, Block7; thence N. 26° 52' E. 60 feet to the S. E. corner of Lot 5 Block 6; thence N. 63° 08' W. 110 feet to the S. W. corner of Lot 5, Block 6; thence S. 26° 52' W. 60 feet to the Point of beginning, all located in First Addition to Chiloquin.

Section 2: The City Recorder is hereby directed to file certified copies of this ordinance with the following offices, to-wit: The County Clerk of Klemath County, Oregon, for recording in Deed Records, the Assessor and Surveyor of said Klamath County, for use in their respective offices.


