WARRANTY DEED

This Indenture Witnesseth, THAT JOHN P. FISHER, his heirs and assigns, the following described premises, situated in Klamath County, Oregon, to-wit:

Lot 1 in Block 1 of FIRST ADDITION TO TONATEE HOMES, according to the official plat thereof on file in the records of Klamath County, Oregon.

Subject to: liens and assessments of Klamath Project and Klamath Irrigation District, and regulations, easements, contracts, water and irrigation rights in connection therewith; Rules, regulations, liens and assessments of South Suburban Sanitary District; Reservations contained in the dedication of First Addition to Tonatee Homes; Building and Use Restrictions recorded October 5, 1959, in Vol. 316 of Deeds, page 226, Records of Klamath County, Oregon, and as amended by instrument recorded September 29, 1961, in Vol. 332, page 660, Deed Records of Klamath County, Oregon; Trust Deed, including the terms and provisions thereof, for beneficiary First National Bank of Oregon, Portland, recorded August 22, 1963, in Vol. 219, page 13, Mortgage Records of Klamath County, Oregon, which said Trust Deed grantee hereby expressly assumes and agrees to pay according to the tenor thereof as same becomes payable and the note accompanying it; and to easements and rights of way of record or apparent on the land, if any.
