DEED OF RECONVEYANCE

KNOW ALL MEN BY THESE PRESENTS, That the undersigned trustee or successor trustee under that certain trust deed dated August 13, 1962, executed and delivered by Hilery Winebarger and Betty Winebarger, husband and wife, (being the same persons as Hilery B.
