EXHIBIT A LEGAL DESCRIPTION ZONE CHANGE 73-88

Legal Description to Accompany Z.C. 73-88 (Keller): A tract of land situate in the SWESNE of Section 7, T395,

RLOEWM, Klamath County, Oregon, described as follows:

Beginning at an iron pin on the east right of way of the Klamath Falls-Merrill Highway from which the southwest corner of Section 7, T395, RLOEWM bears South 910.6' and north 89027' West, 30.0 feet distant; thence south along the said east right of way of said highway, a distance of 459.4 feet; thence east at right angles to the said highway right of way 354.68 feet to the centerline of the Enterprise Irrigation District Canal; thence easterly and northerly along the centerline of said canal, to a point due east of the point of beginning; thence west 965.19 feet to the point of beginning.
