and that the remainder of said lands in said mortgage specified shall remain subject thereto as heretofore.

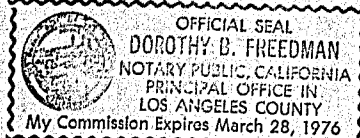
