## OFFICIAL BOND

KNOW ALL MEN BY THESE PRESENTS:

Marion Anderson Miller

1 That  
 2 as Principal (hereinafter called Principal), and the FIDELITY AND DEPOSIT COMPANY OF MARYLAND, a cor-  
 3 poration of the State of Maryland, having its principal office in the City of Baltimore, Maryland, as Surety  
 4 (hereinafter called Surety), are held and firmly bound unto the Klamath County Fair  
 5 Board

6 in the penalty of Ten Thousand and No/100ths Dollars (\$10,000.00)  
 7 to the payment whereof, well and truly to be made and done, the Principal binds himself, his heirs, execu-  
 8 tors, and administrators, and the Surety binds itself, its successors and assigns, jointly and severally, firmly  
 9 by these presents.

12 THE CONDITION OF THE AFOREGOING OBLIGATION IS SUCH, That WHEREAS, the  
 13 Principal was elected or appointed Klamath County Fair Board Director

14 NOW, THEREFORE, if the Principal shall, during the term indefinite  
 15 beginning on the 1st day of January, 1974, well  
 16 and faithfully perform all and singular the duties incumbent upon him by reason of his election or appoint-  
 17 ment as aforesaid, and honestly account for all moneys coming into his hands according to law, then this  
 18 obligation shall be null and void, otherwise of full force and virtue.

19 This Bond is executed by the Surety upon the following express condition, which shall be conditions  
 20 precedent to the right of recovery hereunder:

21 FIRST: That regardless of the number of years this Bond shall continue or be continued in force, or be  
 22 renewed, and of the number of annual premiums that shall be payable or paid, the Surety shall not be liable  
 23 hereunder for more in the aggregate than the above named penalty.

24 SECOND: That the Surety may, if it shall so elect, cancel this Bond by giving thirty (30) days notice in  
 25 writing to Klamath County Fair Board  
 26 and this Bond shall be deemed canceled at the expiration of said thirty (30) days; the Surety remaining  
 27 liable, however, subject to all the terms, conditions and provisions of this Bond, for any act or acts covered  
 28 by this Bond which may have been committed by the Principal up to the date of such cancellation; and the  
 29 Surety shall, upon surrender of this Bond and its release from all liability hereunder, refund the premium  
 30 paid, less a pro rata part thereof for the time this Bond shall have been in force.
