KENNETH E. OTT and KATHERINE C. OTT, husband and wife, Grantors convey and warrant to EDWARD F. CANTY and EDNA MAY CANTY, husband and wife, Grantees, the following described real property situated in Klamath County, Oregon, free of all encumbrances, except as specifically set forth herein:

Lot 6 in Block 8 of TRACT NO. 1037, FIFTH ADDITION TO SUNSET VILLAGE, according to the official plat thereof on file in the office of the County Clerk, Klamath County, Oregon.

S U B J E C T T O :

1. Reservations, restrictions, rights of way and easements of record and those apparent on the land.
2. Liens and assessments of Klamath Project and Enterprise Irrigation District, and regulations, easements, contracts, water and irrigation rights in connection therewith.
3. Any unpaid charges or assessments of the Enterprise Irrigation District.
4. Rules, regulations and assessments of South Suburban Sanitary District.

5. Conditions and Restrictions shown on the plat of Tract No. 1037, Fifth Addition to Sunset village, and reservations and restrictions contained in the dedication of said subdivision, as follows: "...said plat subject to: (1) easements for future public utilities, irrigation and drainage as shown on the annexed plat, easements to provide ingress and egress for construction and maintenance of said utilities, irrigation and drainage, (2) no changes will be made in the present irrigation and/or drain ditches without the consent of the Enterprise Irrigation District, its successors or assigns, (3) building set-back lines as shown on the annexed plat, (4) all easements and reservations of record and additional restrictions as provided in any recorded protective covenants."

Ott, husband and wife, as grantors, to William Ganong, Jr., as trustee, for First Federal Savings and Loan Association of Klamath Falls, Oregon, a corporation, dated February 28, 1973, recorded March 1, 1973, in Vol. M73 page 2135, Microfilm records of Klamath County, Oregon, to secure the payment of \$28,000.00, which Grantees assume and agree to pay.
