EASEMENT

KNOW ALL MEN BY THESE PRESENTS, that NU PACIFIC CO., a corporation, grantor, in consideration of the sum of one dollar (\$1.00) paid it by the CITY OF KLAMATH FALLS, OREGON, the grantee; does hereby grant, bargain, sell and convey unto said grantee, an exclusive easement right for its sewer line to be constructed through, over and across that portion of the NW 1/4 SE 1/4 of Section 14, T39S, R9E, W.M., in said City of Klamath Falls, Oregon, as illustrated on the attached drawing and described as follows; to-wit:

A 10 foot strip of land situated in the NW 1/4 SE 1/4 of Section 14, T39S, R9E, W.M., Klamath County, Oregon, said strip of land being 5 feet on each side of and measured at right angles to the following described centerline:

Beginning at the northeast corner of the NW 1/4 SE 1/4 of said Section 14; thence N89° 56' 41'W a distance of 402.67 feet; thence S 06° 15' 27'W along the westerly right of way line of the Klamath Irrigation District A-3-B irrigation lateral 340.18 feet to the True Point of Beginning of this description; thence N82° 36' 35'W a distance of 146.72 feet, more or less, to the existing sanitary sewer line now located within the proposed right of way of Gatewood Drive;

with the right of ingress and egress on said premises for the purpose of inspecting, repairing, replacing, maintaining, constructing or removing said sewer line or any part thereof and equipment used therewith; provided that in the event of damage to adjacent premises, caused by the grantee, its successors and assigns, the party causing such damage shall repair same and place said premises in as good condition as they were immediately prior to such damage. Grantors agree not to erect any structures within the easement area that would inhibit access to the sewer line, and also agree not to plant within the easement area any variety of Poplar, Elm or Willow trees.
