KNOW ALL MEN BY THESE PRESENTS That First National Bank of Oregon, a national banking association, hereinafter called "Bank", does hereby relinquish any and all right, title, and interest that it received by reason of that certain assignment dated December 5, 1972, and recorded January 16, 1973, in Book M-73, page 515, Records of Klamath County, Oregon. That the real property affected by said assignment, and this relinquishment, is situate in Klamath County, Oregon, and is more particularly described as follows, to-wit:

A tract of land located in the SE1/4NE1/4 and the NE1/4SE1/4 of Section 22, Township 39 South, Range 8 East of the Willamette Meridian, more particularly described as follows:

Beginning at the quarter corner common to Section 22 and 23; thence due South 43.0 feet; thence South 61 deg. 24' West 647.2 feet; thence South 37 deg. 11' East 485.4 feet to the Northwesterly boundary of the Klamath Falls-Ashland Highway; thence along said highway South 39 deg. 31' West 428.7 feet to a 3/4" galvanized iron pipe; thence North 14 deg. 44' West 2441.9 feet to a 3/4" galvanized iron pipe; thence North 89 deg. 25' 45" East 1168.7 feet to a 3/4" galvanized iron pipe; thence South along the Section line between Sections 22 and 23 1303.0 feet to the point of beginning.

That it is not the intention of Bank to discharge or otherwise satisfy the underlying obligation secured by said assignment, but only to release the real property above described from the lien created by said assignment.
