ARTICLE IV - RESIDUE

All of the rest, residue and remainder of the property which I may own, in whole or in part, or to which I may be entitled at the time of my death, real, personal, or mixed, and wheresoever situated, I give, devise and bequeath as follows:

- (1) To my brother, ALBERT MAX SULZ, if he survives me;
- (2) In the event that my said brother does not survive me, or if we die simultaneously, through a common catastrophe, or so close together that it is impossible to tell which died first, then I give, devise and bequeath all of the rest, residue and remainder of my said property to the CHILDREN'S ORTHOPEDIC HOSPITAL AND MEDICAL CENTER, of Seattle, Washington, or its successor.
