## EASEMENT FOR SEWER LINE

That we or I, Pacific & Northwest District of Christian and Missionary Alliance, a Corporation do hereby grant, bargain, sell and convey to the Bly Sanitary District, Klamath County of Oregon, a perpetual easement for the installation, replacement, and repair of and maintenance of a sewer line, to be installed below the surface of the ground, together with rights of access thereto for the purposes stated, on, in and along the following described parcel of land:

The Easterly 12.0 feet of Lots 5 and 6, Block 2, North Bly, Klamath County, Oregon.

Together with the right of ingress and egress over the adjacent lands of the Grantor, his successors and assigns, for the purposes of this easement.

IT IS EXPRESSLY UNDERSTOOD that this easement does not convey the right, title or interest to the surface of the soil, but only the reasonable use thereof, for the purposes here and above stated, not any other rights except those expressly stated in this easement, nor to prevent the Grantors from the full use of the area for purposes not inconsistent with the easement.
