REMOVAL ORDER NO. 74-45

On the 26th day of February, 1940, on recommendation of the Oregon State Board of Forestry, the State Tax Commission, now the Department of Revenue, entered an order classifying certain lands in Klamath County, Oregon, as reforestation lands; and

The Department has found the lands no longer qualify and should be removed from classification; and

In the judgment of the Department, a removal from classification is in the public interest; it is

Therefore ordered, that the described land in Klamath County, Oregon, is hereby removed from Reforestation Classification Order No. 66, and is subject to assessment for ad valorem property taxation.

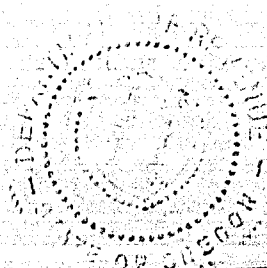
