

KNOW ALL MEN BY THESE PRESENTS, That *OTHA J. SELF*

hereinafter called the grantor, for the consideration hereinafter stated to the grantor paid by *LAWRENCE L. HOBWOOD SR. & LOUISE L. HOBWOOD*, husband and wife, hereinafter called the grantees, does hereby grant, bargain, sell and convey unto the grantees, as tenants by the entirety, the heirs of the survivor and their assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of *CLATSOP*, State of Oregon, described as follows, to-wit:

COMMENCING AT THE ONE-QUARTER CORNER BETWEEN SECTION 36, TOWNSHIP 24 SOUTH, RANGE 8 EAST OF THE WILLAMETTE MERIDIAN, AND SECTION 1, TOWNSHIP 25 SOUTH, RANGE 8 EAST OF THE WILLAMETTE MERIDIAN, AND RUNNING NORTH  $0^{\circ} 32'$  EAST, 881.76 FEET; THENCE SOUTH  $89^{\circ} 15'$  EAST, 671.2 FEET TO THE TRUE POINT OF BEGINNING; THENCE SOUTH  $89^{\circ} 15'$  EAST, A DISTANCE OF 167.8 FEET; THENCE NORTH, A DISTANCE OF 125 FEET; THENCE WEST, A DISTANCE OF 167.8 FEET; THENCE SOUTH, A DISTANCE OF 125 FEET TO THE POINT OF BEGINNING.

To Have and to Hold the above described and granted premises unto the said grantees, as tenants by the entirety, their heirs and assigns forever.

And grantor hereby covenants to and with grantees and the heirs of the survivor and their assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$ *500.00*.

In construing this deed and where the context so requires, the singular includes the plural and all grammatical changes shall be implied to make the provisions hereof apply equally to corporations and to individuals.
