
ORDER

WHEREAS, a public meeting has been held on February 19, 1974 for the purpose of considering the issuance of a provisional Temporary Permit to William E. Gaddis for the placement of a mobile home on that certain real property in Klamath County, Oregon, more particularly described in Exhibit A attached hereto and by reference made a part hereof,

WHEREAS, the Klamath County Board of Commissioners has heard testimony from the applicant and the Klamath County Planning Department concerning this request, and the Board of County Commissioners finding that a Temporary Permit, subject to certain conditions, will not be detrimental to the livability or appropriate development of the area, but will be compatible with abutting properties and the surrounding neighborhood for the duration of the Permit,

NOW, THEREFORE, IT IS HEREBY ORDERED that the Klamath County Board of Commissioners, being authorized by Article 116 of Ordinance No. 17, the same being the Klamath County Zoning Ordinance, does herewith issue a Temporary Permit commencing on the day this Temporary Permit is recorded in the Deed Records of Klamath County, Oregon, for the purpose of the placement of a mobile home on that certain real property in Klamath County, Oregon, more particularly described in Exhibit A attached hereto and by reference made a part hereof, and being further subject to the following provisions and conditions:

Temporary Permit shall run for a period of five
 years from date of recording, or until superseded by such other

permanent zoning provisions as may be initiated by the applicant and approved by the Planning Commission and the Roard of County Commissioners; and

2. The mobile home shall be located in conformance with all property development standards in the present zone; and

3. Wells and septic tanks, installed in association with this Temporary Permit, shall meet all applicable laws.
