Done by the order of the grantor's board of directors with it's corporate seal affixed, this 7th day of May, 1974.

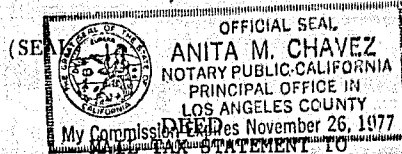
