

WATER RIGHTS

DAVID C. MECKS and BETTY J. MECKS, hereinafter referred to as GRANTORS, are the owners of the following described parcel of land:

S $\frac{1}{2}$  NE $\frac{1}{4}$  NE $\frac{1}{4}$  Sec. 17 and S $\frac{1}{2}$  NW $\frac{1}{4}$  NW $\frac{1}{4}$  Sec. 16, Township 39 S.

Range 8E., W.M. County of Klamath, State of Oregon.

WHEREAS, on said parcel of land there is a 15,000 gallon water tank, well, pump and water distribution lines, Collectively hereafter referred to as the WATER SYSTEM, and

WHEREAS, the Grantors do desire to transfer an undivided one-third (1/3) interest in said Water System to EUGENE CORRYELL, hereinafter referred to as GRANTEE,

NOW, THEREFORE, for \$10.00 and other good and valuable consideration, the receipt of which is hereby acknowledged, GRANTORS do hereby grant an undivided one-third (1/3) interest in and to said Water System, and the right to take one-third (1/3) of water therefrom, to GRANTEE FOR DOMESTIC AND IRRIGATION PURPOSES.

This Agreement is expressly made on the condition that and so long as Grantee shall pay, upon demand, one-third (1/3) of the cost and expense of maintenance, repair, improvement and upkeep of the well, water, tank, pump, distribution system and all other expenses in connection therewith. Grantee is hereby given the right of access over and across Grantors' land for the purpose of performing maintenance and inspection of the Water System as may be required.

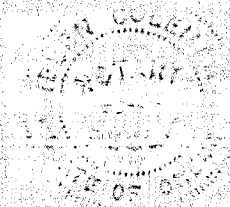
