MODIFICATION OF MORTGAGE

THIS AGREEMENT, MADE AND ENTERED INTO THIS _ 29th DAY OF _ AND BETWEEN

THE FIRST INSTALMENT SHALL BE AND IS PAYABLE ON THE 25+4 RATE OF 2.0 dul n 19 71 AND A LIKE INSTALMENT ON THE 2500 DAY OF EACH MONTH THERE-DAY OF AFTER UNTIL THE PRINCIPAL AND INTEREST ARE FULLY PAID, EXCEPT THAT THE FINAL PAYMENT OF PRINCIPAL AND INTEREST IF NOT SOONER PAID, SHALL BE DUE AND PAYABLE ON THE 25th DAY OF October 19 71 .
