

JOLLIFF, husband and wife, the party of the second, part, the receipt of which is hereby acknowledged, has granted, bargained, sold, assigned, transferred and set over, and by these presents does grant, bargain, sell, assign, transfer and set over unto the said party of the second part, an undivided interest in and to a certain INDENTURE OF MORTGAGE bearing date the 14th day of June, 1974, made and executed by GATEWAY CATTLE COMPANY,
