The northwest quarter of the southwest quarter of Section 35, Township 35 South, Range 11 East, Willamette Meridian, consisting of forty (40) acres, subject to covenants, reservations, and easements of record and reserving 15 feet along the southern boundary for road easement.

Seller hereby grants to buyers any and all mineral rights he has in the forty acres.


