11 This matter came on for trial on September 19, 1972.

12 Petitioner appeared in person and by her attorney, CRAIG C. COYNER.
13 Respondent did not appear and was found in default.

14 The Court finding that irreconcilable differences exist
15 between the parties making continuation of the marriage relationship
16 impossible and that the parties were married on March 28, 1949 at
17 Klamath Falls, Oregon, and that two (2) children were born during
18 the marriage, namely: GREGORY G. SMITH, son, born July 23, 1953,
19 and DANA MARIE SMITH, daughter, born April 7, 1957.

21 IT IS HEREBY DECREED THAT:

22 1. The marriage of the parties is hereby dissolved and
23 said dissolution is finally effective November 30, 1972.

24 2. Petitioner is awarded custody of DANA MARIE SMITH and
25 Respondent shall have reasonable visitation of said child. Respondent
26 shall have custody of GREGORY G. SMITH and Petitioner shall have
27 reasonable visitation of said child.

28 3. Respondent shall pay each month on or before the 15th day of the month
29 the sum of \$100.00 for the support and maintenance of DANA
30 MARIE SMITH, together with such other collection service fees as are

1 charged by the County Clerk's office for Deschutes County, together
 2 with \$100.00 alimony per month for the Petitioner, also payable
 3 commencing October 10, 1972.
