WHEREAS, in a suit in the Circuit Court of the State of Oregon for Klamath County, Oregon, between AMERICAN CITY BANK, a California Banking Corporation, Plaintiff, and JOHN N. WAIN, WINIFRED G. WAIN, J. W. COPELAND YARDS, an Oregon Corporation, and FRANK COTTON, Defendants, a judgment and decree was entered on May 10, 1973, for the foreclosure of a mortgage on the real property described below; and
