## CERTIFICATE FOR ORDAINED MINISTER

THIS IS TO CERTIFY that ZANE LEE HRICZISCSE is a minister of Jehovah God, recognized as such by Jehovah's Christian witnesses and by their legal agency, the Watchtower Bible and Tract Society of New York, Inc.

Besides carrying out these duties of a minister of Jehovah's Christian witnesses, he has been officially ordained to special service and is currently serving for those duties as a Regular Pioneer minister.

He is therefore certified by this Society to be, in accord with its principles, a duly ordained minister.
