

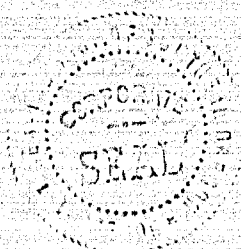
PARTIAL RELEASE OF MORTGAGE

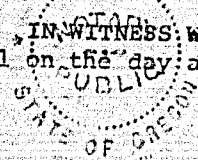
