KNOW ALL MEN BY THESE PRESENTS, that LEWIS I. MOORE and FERN M. MOORE, husband and wife, hereinafter called "Grantors", do hereby grant and convey unto WEYERHAEUSER KLAMATH FEDERAL CREDIT UNION, hereinafter called "Grantee", and its successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath, and State of Oregon, described as follows, to-wit:

The tract of land formerly included in the plat of West Klamath (but in the part thereof which has been vacated) described as follows on said plat as recorded in the Office of the County Clerk of said County:

That portion of Lot 73 of Block 40, which lies Westerly of the Easterly line of Lot 67 of said Block 40, extended Southeasterly to the South line of said Lot 73, less and except the Westerly 10 feet thereof, as conveyed by Holliday Land Company to Klamath County, on Page 142 of Volume 95 of Deed Records of Klamath County.

TO HAVE AND TO HOLD the same unto the said Grantee and its successors and assigns, forever.

This deed is granted, for no monetary consideration, for the purpose of describing, as a single tract, or piece, of land, the two parcels of land conveyed by Grantors' herein to Grantee herein by deeds recorded in Volume 323, Page 585 and Volume 352, Page 132, Deed Records of Klamath County and to evidence that it was the intent of Grantors' to convey to Grantee two (2) abutting, contiguous parcels of land forming a single tract, or piece of land.

In construing this deed the singular includes the plural as the circumstances may require.

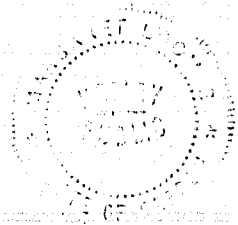
