This matter having come on to be heard on this 6th day of September, 1974,
at the hour of 10:00 a.m., before the Board of Directors of Klamath Irrigation
District, at the office of said Board at 6640 K.I.D. Lane, Klamath Falls,
Oregon, upon the Petition of Melvin L. Stewart; Maurice E. Bercot; Elmer D.
Husted and Arlene M. Husted, husband and wife; and R. A. Coffman and Mary
Robbie Coffman, husband and wife, for the exclusion of lands hereafter descri-
bed from the Klamath Irrigation District pursuant to the provisions of ORS
545.602 to 545.620, this being the time and place heretofore set by said Board
for the Hearing on said Petition, and said Board proceeding to hear said Peti-
tion, finds as follows:

That on August 2, 1974, said Petitioners filed with the Board of
Directors their duly verified Petition praying that their lands consisting of
9.55 acres, more or less, in Klamath County, State of Oregon, which said lands
are in this Order hereinafter more particularly described, be excluded from
Klamath Irrigation District pursuant to the provisions of ORS 545.602 to
545.620.

1 said petition the sum of \$1,528.00, which said sum was determined by said
2 Board of Directors to be amount provided and required by ORS 545.613.

3.

4 That the Secretary of the Board of Directors of Klamath Irrigation Dist-
5 rict caused Notice of the filing of said Petition to be duly published once a
6 week for two weeks in the Herald and News, a newspaper of general circulation
7 published in Klamath County, the County where the Board of Directors of
8 Klamath Irrigation District is situated. That the Notice stated the filing
9 of the Petition, the name of Petitioners, a description of the lands mentioned
10 in the Petition, and the Prayer of the Petitioners, and Notified All Persons
11 interested in, or who may be affected by such change of the boundaries of the
12 District to appear at the office of the Board at 6640 K.I.D. Lane, Klamath
13 Falls, Oregon, at 10:00 a.m. on September 6, 1974, and show cause in writing,
14 if any they have, why the change in boundaries proposed in the Petition should
15 not be made. That the time so specified in said Notice at which they were
16 required to show cause was the regular Meeting of the Board next after the
17 expiration of the time for the publication of said Notice.
