That I was well acquainted with Annie Maria Cobb Clark, hereafter referred to as Annie M. Clark, being a grandson. That she was married only once, and then to Absalom Thomas Clark, hereafter referred to as A.T. Clark, who was the owner of the following described land, situated in the State of Oregon, to-wit: in the County of Klamath, Twp. 39S., Rge. 15E., Sec. 25, N. 1/2, S. 1/2, and in the County of Harney, Twp. 36S., Rge. 29E., Sec. 29, N. 1/2, S. 1/2.

That this land was not occupied as a homestead of the deceased, and that this land is not now occupied. There were no minor children of the deceased living at the time of her death.

That Annie M. Clark died on the 22d day of October, 1944, subsequent to the death of A.T. Clark. That she left no will and there was no estate probated. That she lived in Clarinda, Iowa located in Page County, Iowa, at the time of her death.

Bertram T. Clark: survived by a widow and one son, Bertram T. Clark, Jr.

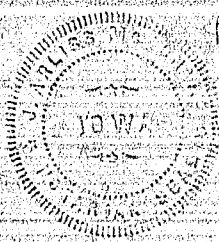
Iva Maud Collins: Left two children, Thomas C. Collins and Robert R. Collins.
