

CLAIM FOR FARM LABOR

KNOW ALL MEN BY THESE PRESENTS: That M. A. HANNIGAN, also known as BUD HANNIGAN, hereinafter called the Claimant, has performed farm labor and services under a contract between Claimant and the duly authorized Personal Representative of the Estate of ALBERT A. LANG, deceased, upon certain lands located within Klamath County, State of Oregon, more particularly described as follows:

IN TOWNSHIP 35 SOUTH, RANGE 10 EAST OF THE WILLAMETTE MERIDIAN:

Section 31: S $\frac{1}{2}$ S $\frac{1}{2}$ N $\frac{1}{2}$ E $\frac{1}{2}$, S $\frac{1}{2}$ N $\frac{1}{2}$ E $\frac{1}{2}$, SE $\frac{1}{4}$ and that portion of the S $\frac{1}{2}$ N $\frac{1}{2}$ SE $\frac{1}{4}$ NW $\frac{1}{4}$, S $\frac{1}{2}$ SE $\frac{1}{4}$ NW $\frac{1}{4}$, N $\frac{1}{2}$ SW $\frac{1}{4}$ and the SE $\frac{1}{4}$ SW $\frac{1}{4}$ lying East of the Sprague River.

Section 32: That portion of the S $\frac{1}{2}$ SW $\frac{1}{4}$ lying West of the Sprague River.

IN TOWNSHIP 36 SOUTH, RANGE 10 EAST OF THE WILLAMETTE MERIDIAN:

Section 5: Lot 4, SW $\frac{1}{4}$ NW $\frac{1}{4}$ and that portion of Lot 3 and the SE $\frac{1}{4}$ NW $\frac{1}{4}$ lying West of Sprague River.

Section 6: Lots 1 and 2, S $\frac{1}{2}$ N $\frac{1}{2}$ E $\frac{1}{2}$, and that portion of Lot 3, SE $\frac{1}{4}$ NW $\frac{1}{4}$ and the NE $\frac{1}{4}$ SW $\frac{1}{4}$ lying East of the Sprague River.

That there is now due, owing and unpaid, after deductions, credits and offsets, the sum of \$1,000.00.

The name of the owner or reputed owner of the property to be charged with the Lien, is AUDREY HENRY, Personal Representative of the Estate of ALBERT A. LANG, and the claimant was employed by ENVER BOZGOZ, Attorney for the Personal Representative, above-named.

Claimant claims liens upon 150 tons of hay, located upon the above-described land.

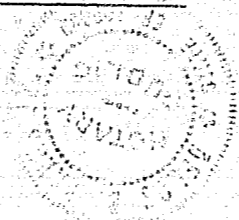
