CERTIFICATE OF WATER RIGHT

This Is to Certify, That J. C. EDSALL AND T. M. EDSALL

of Bly, State of Oregon, has a right
to the use of the waters of South Fork of Sprague River

a tributary of Sprague River for the purpose of
irrigation of 54.4 acres, domestic and stock use
and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for
Klamath County, and the said decree entered of record at Salem, in the Order Record of
the STATE ENGINEER, in Volume 10, at page 236; that the priority of the right thereby
confirmed dates from 1900

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an
amount actually beneficially used for said purposes, and shall not exceed one-fortieth of a
cubic foot per second per acre, prior to June 15th, and one-eightieth of a cubic
foot per second per acre after June 15th, with a total limitation of three acre
feet per acre from March 1st to October 1st of each year.

The point of diversion is located in the NW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 8, Township 37 South, Range
15 East, W.M.

A description of the place of use under the right, and to which such right is appurtenant, is as
follows:


37.5 acres NE $\frac{1}{4}$ NE $\frac{1}{4}$
6.5 acres NW $\frac{1}{4}$ NE $\frac{1}{4}$
10.4 acres SE $\frac{1}{4}$ NE $\frac{1}{4}$
Section 3
T. 37 S., R. 14 E., W.M.

Certificate of water right issued to J. C. Edsall and T. M. Edsall and recorded
at page 9970, Volume 9, State Record of Water Right Certificates confirms the
right to the use of water for irrigation of 76.2 acres. Subsequently, the right
to the use of water appurtenant to 21.8 acres was canceled by order of the State
Engineer entered October 10, 1974. This certificate is issued to confirm the
remaining right to the use of water for irrigation and supersedes the certificate
heretofore issued to J. C. Edsall and T. M. Edsall.

And said right shall be subject to all other conditions and limitations contained in said decree.
The right to the use of the water for the purposes aforesaid is restricted to the lands or place
of use herein described.
