

EASEMENT FOR WATER LINE

That we, Bob Fanning and Beatrice L. Fanning, husband and wife, do hereby grant, bargain, sell and convey to the City of Malin, Oregon, a perpetual easement for the installation, replacement, and repair of and maintenance of a water line, to be installed below the surface of the ground, together with rights of access thereto for the purposes stated, in and along the following described parcel of land:

An Basement, 20 feet in width, for ingress and egress, for installation and maintenance of a water line, the center line is described as follows:

Beginning at the South East property corner of said property described in Volume 331, Page 544; thence North 97 feet along the West boundary of 5th Street to the center line of said Basement; thence West to the Western boundary line of said property described in Volume 331, Page 554. (Bearings are based on the supplemental plat of the City of Malin)

Together with the right of ingress and egress over the adjacent lands of the Grantor, his successors and assigns, for the purposes of this easement.

IT IS EXPRESSLY UNDERSTOOD that this easement does not convey the right, title or interest to the surface of the soil, but only the reasonable use thereof, for the purposes here and above stated, not any other right except those expressly stated in this easement, nor to prevent the Grantor from the full use of the area for purposes not inconsistent with the easement.
